
MFJ-917 1:1 SWR Analyzer CURRENT BALUN 1.8-30 MHz

INTRODUCTION

The **MFJ-917** is a true 1:1 current balun designed for the measurements of balanced lines using SWR and Antenna analyzers. It is rated from 1.8 to 30 MHz. It has a SO-239 coax connector with internal insulation for the maximum life of the product.

INSTALLATION

1. The **MFJ-917** is intended for applications protected from the elements – *out of the weather*.
2. For use as a balun (1:1) connect the balanced feed line to the posts and the SWR/Antenna Analyzer coaxial cable to the SO-239 coax connector.

FULL 12-MONTH WARRANTY
